**Macomb County MSO Board
Of Directors Report
Meeting Sunday, June 13, 2010**

Good afternoon Macomb. All is well at the office.

Our office worker who took a temporary leave will be coming back to work this June. We are also going to consider re-opening the office on Fridays but have not made a firm decision on that.

The Regional Helpline Co-Chair came in and said the door was locked to the Helpline room and he was unable to get in. In case anyone heard the rumor we wanted to make everyone aware the regional chair has a key, and decides who can actually have access to it. There is also a key kept in the office for helpline workers if they come in during office hours. Dave C. also has a key. So I think it may have just been some mis-communication between the Chair and Co-Chair.

Aaron G. which is the Detroit West seat will be resigning his seat on the board and this was his last meeting. This will now open up seat 7. In addition to this seat we have seat 1 Metro Detroit Region, seat 11 Blue Water, seat 14 regional at-large.

Our financials are as follows: DACNA convention sales were \$12,424.66. April total sales were \$29,597.35 (without DACNA it would have been \$17,172.69). After all income and expenses for the month we had a net income of \$3,061.83.

I have been asked by the office manager to get an updated list of the current Admin body as well as all of the Chairs for the sub-committees. I will pass a sheet out and would like to get it filled in and back by the end of the meeting.

We had quite a bit of discussion in our April meeting pertaining to material sold at the MSO that some members felt endorsed outside enterprises. We were going to analyze the items we had and remove them. However, two of our board members went to the NAWS conference and took a few of the items with quotes from "famous people". The consensus of the members they spoke with at NAWS, said the people who the quotes were from were deceased, and said as long as we don't put our Logo on them they should be okay. Since we have so much money tied up in our current inventory we should go ahead and sell what we have but not order more. A vote was taken to sell what we have and do some more research to see if we want to order more. That concludes my report for this month.


