## H&I Inmate Release Program

I'm an addict named Marty K.

Over the past year we have been in the process of putting together an Inmate release program for the Macomb County Jail. We finally put the finishing touches on two I.P.s, to help our efforts at H&I. The first I.P. is for Inmates who are within 3 to 6 months of release. They can fill out the form on the I.P. and request an NA member to meet them when they get out of jail. The second I.P. is for NA members with two years clean to volunteer to be the member who meets the inmate when they get out. Inmates will send their request to our P.O. Box. Our H&I committee member will be the liaison between the Inmate and volunteer. The volunteer will write the inmate to discuss where and when would be the best time to meet. We hope this will help set ~~our~~ inmates up for success in stay clean when they are released. Our I.P.s have been approved by the Macomb County Jail.
